# Research Workshop Proceedings

## #Opening Remarks

The research workshop was opened by Rodger Wilson, Executive Director of the Migration Policy Centre, who welcomed all participants and introduced them to the Centre and its framework and publications, to the migration project 'Protecting the Rights of Migrants: Initiating Policy Analysis, Public Outreach and Stakeholder Dialogue to Mobilise Action towards Reform' and the workshop objectives and the program. At the end of his welcoming speech the Director expressed confidence in holding productive discussion at the workshop.

## (Session I) Protection of Migrant Rights

The session began with several presentations and an introductory briefing on migration issues. The key topics discussed in the workshop were the abuse by employers and recruiting agencies, xenophobia and discrimination, and lack of access to basic services. The cross-cutting themes discussed at both sessions were diaspora and business communities and their role in migrants; rights protection. Adoption of new technologies was another common theme throughout the whole discussion.

Migrant workers face discrimination in employment in terms of poor work conditions, withholding of passports and documents, nonpayment for services or long delays in payment, violence or threats against them (illegal registration, fraudulent work permits, and deceptive advertising were listed among the causes and consequences of mistreatment of migrants). Moreover, their discrimination leads to migrants working in hazardous or abusive conditions.

than one million Kyrgyzstani labor migrants stay and work in the EU which allows them to help their families in Kyrgyzstan significantly.
